**FINAL ORDER IN GARNISHMENT**

The Plaintiff(s) in this matter have a judgment against the Defendant. The Court, having considered evidence presented, now finds that Plaintiff is entitled to recover from the earnings of Defendant the amount required to satisfy the judgment of \$\_\_\_\_\_, plus post-judgment interest and sheriff’s service fees, until the judgment is fully paid and satisfied. Pursuant to I.C. 34-4.5-5-105(5), the Garnishee Defendant (“Employer”) is entitled to a fee of 3% of the amount to be collected or \$12.00, whichever is greater, one-half (1/2) of the fee to be paid by the Plaintiff, and one-half (1/2) of the fee to be paid by Defendant.

**The Wayne County Clerk of Courts may notify Employer of the total amount of post-judgment interest and sheriff’s service fees to be submitted prior to the final garnishment order being released.** Final garnishment orders take priority in the order in which they are received, except for deductions for child support. Child support deductions shall be considered garnishments, and take priority over all other garnishments when received. Deductions for more than one garnishment may be made, but only up to the maximum deduction.

IT IS, THEREFORE, ORDERED that:

1. Garnishee Defendant (Employer) shall pay at least monthly to the Wayne County Clerk of Courts:
  - a. the amount by which Defendant’s weekly disposable earnings exceed thirty (30) times the current minimum wage; or
  - b. 25% of Defendant’s disposable income, whichever is less, until \$ \_\_\_\_\_ [total amount owing] has been paid to the Wayne County Clerk of Courts, **plus post-judgment interest and Sheriff’s service fees.** Disposable earnings means income remaining after deductions for federal, state, county, and local income tax and federal Social Security tax, if any.
2. Garnishee Defendant (Employer) shall **send payments with the Defendant’s name and this case’s Cause Number to the Wayne County Clerk of Courts, Small Claims Division, 301 East Main Street, Richmond, Indiana, 47374.**
