NOTICE OF PUBLIC HEARING

The Wayne County, Indiana Board of Commissioners will hold a public hearing on Wednesday, June 24, 2026 at 9:15 a.m. in the Commissioner/Council Chambers, Wayne County Administration Building, 401 East Main Street, Richmond, Indiana. Pursuant to the provisions of Wayne County Resolution No. ACP 2026-01, the following proposed ordinance will be considered.

Proposed Ordinance No. 2026-005, which reads in part:

To vacate eight (8), undeveloped, platted ways as depicted in the recorded plat of Abington, now the unincorporated town of Abington, Abington Township, in the R-1 One-Family Residence District. Specifically, the vacation of (1) all of the 15 foot wide public way also known as Back Street, commencing at a point 15 feet south of lot 126 into the platted way also known as South Street, then north to Pottershop Road; and (2) the vacation of all of an un-named 10 foot wide public way, commencing at a point 15 feet south of lots 125 and 126 into the platted way also known as South Street, then north to Pottershop Road; and (3) the vacation of all of a 50 foot wide public way also known as 3rd Street, commencing at a point 15 feet into the platted way also known as South Street, south of lots 124 and 125, then north to the south lot line of lot 76; and (4) the vacation of parts of an un-named 10 foot wide public way, commencing at a point 15 feet south of lots 123 and 124 into the platted way also known as South Street, then north to the south side of the platted way also known as Walnut Street; and, (5) the vacation of all of a 15 foot wide platted way also known as South Street, 15 feet into the platted way also known as Back Street, then east to Abington Pike; and, (6) the vacation of a 10 foot wide un-named platted way, commencing at a point 15 feet into a platted way also known as Back Street, and then commencing east to lots 106 and 111; and, (7) the vacation of a 50 foot wide platted way also known as Walnut Street, commencing at a point 15 feet into a public way also known as Back Street, then commencing east to lots 87 and 94; and, (8) the vacation of an unnamed public way, 15 feet into the platted way also known as Back Street, then east to lots 68 and 77.

Comments will be heard by the Wayne County, Indiana Board of County Commissioners from all parties interested in or affected by the proposed ordinance. A complete text of the proposed ordinance may be viewed in advance of the hearing in the office at the Wayne County Plan Commission, 401 East Main Street, Richmond, Indiana 47374.
